

# CHILD HEALTH RECOGNITION AWARDS PROGRAM

**2020 Focus Area:** *Individuals and programs addressing evidenced-based issues of significance to the community being served and working in partnership with others to help improve health outcomes for children. Including partnerships that focus on the following health problems: asthma, dental health, environmental health (healthy homes), immunizations, low-birth weight, mental health, nutrition, and substance abuse including drugs, alcohol and tobacco.*

*The North Carolina GlaxoSmithKline Foundation supports the Child Health Recognition Awards Program, which recognizes public health workers and programs that improve the health status of children. The program honors North Carolina public health professionals and departments for innovative, creative and successful approaches to improving the lives of our younger generations. Awards are tentatively scheduled to be presented at the 2020 North Carolina Public Health Association's annual meeting.*

NCPHA manages the nomination and selection process. Nominations for the Child Health Recognition Awards Program may be made by anyone who has sufficient knowledge about the individual's activities or local health department's services. Nominations are evaluated by a selection committee made up of health care professionals.

## *Awards are made in four categories:*

**The Lifetime Achievement Award** will be given to an individual who has made an outstanding contribution to improving children's health services through a series of achievements over a period of time. The award will consist of a monetary grant of up to \$4,000 to be given to the state public health association for scholarship in the name of the award recipient.

**The Individual Recognition Award** will be given to an individual who has made an outstanding contribution to improving children's health services through a single effort. The award will consist of a monetary grant of up to \$4,000 to be given to the state public health association for scholarship in the name of the award recipient.

**The Local Health Department Recognition Award** will recognize local health departments that have developed an innovative program that has produced measurable, sustainable outcomes. All local health departments, as defined by NCGS 130A-2(5) are eligible for consideration. Up to three local health departments will receive awards consisting of monetary grants of up to \$10,000 to be used by the grantees for activities such as special projects, staff development or educational materials.

**The Public Health Staff Recognition Award** will be given to an individual who is either a full-time or part-time employee or retiree of a local health department in recognition of outstanding service in preventive health activities in their local community. Awards will be made consisting of monetary grants of up to \$2000, to be used by the grantee for activities such as special projects, personal development or educational materials.
